

First, you must be able to confirm that there are any top prizes remaining.

Another condition is that the winning gold ball must have been removed from the machine.

In other words, this is if the store is cheating.

Displaying something that is an absolute non-win as a prize is fraud.

The motive for fraud is to prevent the top prizes from running out and reducing the number of shoppers hoping to win the lottery.

A raffle where you can't check which prizes are remaining eliminates the incentive.

How to guarantee a prize at lottery machine

Expected value

A typical lottery machine holds 300 balls.

$$\text{The expected value of winning gold ball in the machine} = \frac{\text{Number of top prizes}}{\text{Expected number of draws} / 300}$$

The expected value of winning gold ball in the machine can be calculated if the expected number of draws is known.

The smaller the expected value is below 1, the higher the probability that the machine is being rigged.

It is possible to guess if a lottery is being rigged.

A typical lottery machine holds 300 balls.

The expected value of winning gold ball in the machine can be calculated if the expected number of draws is known.

The smaller the expected value is below 1, the higher the probability that the machine is being rigged.

If more gold balls are put in than the expected value, the prizes will run out early.

Since only integer numbers of balls can be put in, this leads to the idea that only 0 balls can be put in.

How to guarantee a prize at lottery machine

Expected number of lottery draws

- (1) Estimate the number of lottery tickets from average sales.
- (2) Monitor the store for a certain period of time and measure the number.
- (3) Estimate the number of lottery draws
from the number of second-prize prizes or lower.

The only way to confirm whether someone is actually cheating
is to look inside the lottery machine.

There are three ways to estimate the expected number of lottery draws.

- (1) Estimate the number of lottery tickets from average sales.
- (2) Monitor the store for a certain period of time and measure the number.
- (3) Estimate the number of lottery draws from the number of second-prize prizes or lower.

Statistical tests can also be used to calculate the risk of cheating.


The only way to confirm whether someone is actually cheating is to look inside the lottery machine.

To catch a cheater in the act, you need to do it in the first half of the lottery draw.

This is because cheaters will stop cheating in the second half of the draw.

Sting operation



To catch the scammer in the act, stage a scam.


- (1) Reverse the rotation of the lottery machine.
- (2) Drop a suitable sphere into the machine and let it roll.
- (3) Have the store clerk follow the sphere with their eyes.

- (6) The clerk will say something like, "There's no way it'll come out."
- (7) You should then say, "If it's designed so that it never comes out, it's a scam."

How to guarantee a prize at lottery machine

Route branching

"If it's not a scam, let me take a look inside the lottery machine"

It's almost certainly a scam, but you have no evidence.

No "If there's a winning ball inside,
there shouldn't be any problem with me admitting that I won"

you'll just take the prize, give up on exposing the scam, and go home.

Yes Since the number of golden balls has
increased, people will suspect you of
cheating in the future.

To the withdrawal plan

Say, "If it's not a scam, let me take a look inside the lottery machine".

This explains the steps you should take if they refuse.

It's almost certainly a scam, but you have no evidence.

Say, "If there's a winning ball inside, there shouldn't be any problem with me admitting that I won".

Unfortunately, you'll just take the prize, give up on exposing the scam, and go home.

On the other hand, this explains the steps you should take if they let you see the inside of the lottery machine.

There's nothing suspicious there, and the golden ball is probably inside.

Since the number of golden balls has increased, people will suspect you of cheating in the future.

I have plenty of withdrawal plans prepared.

How to guarantee a prize at lottery machine

Plan A

"I won, and then I feel bad about being suspected, so I don't want any more"

If you feel like you're in a bad position, make a quick decision and back out.

Plan B

The increase in the number of gold balls was a mistake on the part of the store.

Since neither side has conclusive evidence,
you'll just have to pretend nothing happened.

Plan C

Tell them it was a sting operation and apologize.

Explain that you were just putting up a show to confirm the scam,
and that you had no intention of taking the prize.

Plan A is to say, "I won, and then I feel bad about being suspected, so I don't want any more".

If you feel like you're in a bad position, make a quick decision and back out.

Plan B is to claim that the extra gold balls were a mistake on the part of the store.

Since neither side has conclusive evidence, you'll just have to pretend nothing happened.

For this plan, you'll need to use something that is indistinguishable from a real gold ball.

Plan C is to be honest and apologize, explaining that it was a sting operation.

Explain that you were just staging it to test the waters and had no intention of stealing any prizes.

How to guarantee a prize at lottery machine

Plan D Chocolate ball coated in gold leaf

"It was on my sleeve and just fell off by accident"



Plan E Pachinko ball dyed gold



"It got caught in my hair and just fell off by accident"

"When I dyed my hair, the pachinko balls got dyed too"

For Plan D, you'll use a chocolate ball coated in gold leaf.

You'll claim that it was on your sleeve and fell out by accident.

For Plan E, you'll use a pachinko ball dyed gold.

You'll claim that it was stuck in your hair and fell out by accident.

For this plan, you'll need blonde, curly hair.

You'll claim that when you dyed your hair, the pachinko ball got dyed too.

How to guarantee a prize at lottery machine

Precautions

Evidence obtained through illegal manipulation will not be admissible in court.

Even if you are trying to expose a scam, you should not do anything bad.

However, to the extent that it can happen by chance,
it cannot be ruled out as malicious.
